Waiver from participation may be granted at the discretion of the administrator for students who are already covered under certain government or embassy sponsored plans. Eligible Dependents are the student's legal spouse and dependent children under 26 years of age.

No benefits will be paid for: a) loss or expense caused by, contributed to, or resulting from; or b) treatment, services or supplies for, at, or related to any of the following:

- 3. Biofeedback.
- 4. Circumcision.
- 5. Congenital Conditions, except as specifically provided for:
 - Habilitative Services.
 - Newborn or adopted Infants.
 - Cosmetic procedures, except reconstructive procedures to:
 - Correct an Injury or treat a Sickness for which benefits are otherwise payable under this policy. The primary result of the procedure is not a changed or improved physical appearance.
 - Treat or correct Congenital Conditions of a Newborn or adopted Infant.
- 7. Dental treatment, except:
 - For accidental Injury to Sound, Natural Teeth.
 - This exclusion does not apply to benefits specifically provided in Pediatric Dental Services.
- 8. Elective Surgery or Elective Treatment.
- 9. Flight in any kind of aircraft, except while riding as a passenger on a regularly scheduled flight of a commercial airline.
- 10. Health spa or similar facilities. Strengthening programs.

Research or examinations relating to research studies, or any treatment for which the patient or the patient's representative must sign an informed consent document identifying the treatment in which the patient is to participate as a research study or clinical research study, except as specifically provided in the policy.
- 24. Routine eye examinations. Eye refractions. Eyeglasses. Contact lenses. Prescriptions or fitting of eyeglasses or contact lenses. Vision correction surgery. Treatment for visual defects and problems. This exclusion does not apply as follows:
 - When due to a covered Injury or disease process.
 - To benefits specifically provided in Pediatric Vision Services.
 - To one pair of eyeglasses or contact lenses to replace the human lens function as a result of eye surgery or eye Injury or defect.
- 25. Routine Newborn Infant Care and well-baby nursery and related Physician charge, except as specifically provided in the policy.

 - Screening exams or testing in the absence of Injury or Sickness.
- 27. Services provided normally without charge by the Health Service of the Policyholder. Services covered or provided by the student health fee.
- 28. Skeletal irregularities of one or both jaws, including orthognathia and mandibular retrognathia. Temporomandibular joint dysfunction. Deviated nasal septum, including submucous resection and/or other surgical correction thereof. Nasal and sinus surgery, except for treatment of a covered Injury or treatment of chronic sinusitis.
- 29. Skydiving. Parachuting. Hang gliding. Glider flying. Parasailing. Sail planing. Bungee jumping.
- 30. Naturopathic services.
- 31. Supplies, except as specifically provided in the policy.
- 32. Surgical breast reduction, breast augmentation, breast implants or breast prosthetic devices, or gynecomastia, except as specifically provided in the policy.
- 33. Treatment in a Government hospital, unless there is a legal obligation for the Insured Person to pay for such treatment.
- 34. War or any act of war, declared or undeclared; or while in the armed forces of any country (a pro-rata premium will be refunded upon request for such period not covered).
