Who is eligible to enroll?

- All Domestic Undergraduate students taking 5 or more credit hours and all Domestic Graduate students taking 3 or more credit hours are eligible to enroll in this insurance plan on a voluntary basis.
- All approved Domestic Graduate Assistants, Domestic Graduate research assistants, Domestic Graduate teaching assistants and Domestic Graduate fellowship students taking at least 3 credit hours per semester and all international visiting scholars under UA J-1 Visa Sponsorship are eligible to enroll in this insurance plan on a voluntary basis. Students taking internet classes in addition to taking the required number of credit hours in an on-campus classroom are eligible to enroll on a voluntary basis. Students classified as Distance Learning primarily enrolled in internet classes are not eligible to enroll in this plan. Main Campus students in courses designated as On-line Main (OLM) will remain eligible.
- All International and English Language Institute students are required to enroll in this insurance plan on a hard waiver basis, including all approved International Graduate assistants, International Graduate research assistants, International Graduate teaching assistants and International Graduate fellowship students taking at least 3 credit hours per semester.

Eligible students who do enroll may also insure their Dependents. Eligible Dependents are the student's legal spouse and dependent children under 26 years of age.

The student (Named Insured, as defined in the Certificate) must actively attend classes for at least the first 31 days after the date for which coverage is purchased. Home study, correspondence, and online courses do not fulfill the eligibility requirements that the student actively attend classes. The Company maintains its right to investigate eligibility or student status and attendance records to verify that the Policy eligibility requirements have been met. If and whenever the Company discovers that the Policy eligibility requirements have not been met, its only obligation is refund of premium.

The eligibility date for Dependents of the Named Insured shall be determined in accordance with the following:

- 1. If a Named Insured has Dependents on the date he or she is eligible for insurance.
- 2. If a Named Insured acquires a Dependent after the Effective Date, such Dependent becomes eligible:
 - a. On the date the Named Insured acquires a legal spouse.
 - b. On the date the Named Insured acquires a dependent child who is within the limits of a dependent child set forth in the Definitions section of the Certificate.

Dependent eligibility expires concurrently with that of the Named Insured.

Student Health Center Message

SHC and UMC Benefits: The Deductible will be waived and benefits will be paid at 100% for Covered Medical Expenses incurred when treatment is rendered at the Student Health Center (students only) or University Medical Center (students or insured dependents). Services provided by a Certified Registered Nurse Practitioner (CRNP) and University of Alabama's licensed medical residents are paid as any other Physician's Visit. There is a \$20 Copay per visit for office visits for non-preventative care physician visits.

The \$20 Copay applies to all services rendered at the SHC & UMC, except physician visits for preventative care where the copay will be waived. There will be (1) copay taken for all services rendered per date of service.

TB testing is covered at the SHC and UMC at 100% after a \$20 Copay per visit (for students only).

Preventive care office visits (includes immunizations) are provided at the SHC with no Copays.

If a student is seen by any provider other than at SHC or UMC without a referral from the SHC or UMC, then benefits will be paid at the Out-of-Network level of benefits.

Prescriptions dispensed at the Student Health Center - \$10 Copay per prescription for Tier 1 / \$40 Copay per prescription for Tier 2 / \$50 Copay per prescription for Tier 3.

Exclusions and Limitations

No benefits will be paid for: a) loss or expense caused by, contributed to, or resulting from; or b) treatment, services or supplies for, at, or related to any of the following:

- 1. Acupuncture.
- Biofeedback.
- Circumcision.
- 4. Cosmetic procedures, except reconstructive procedures to correct an Injury or treat a Sickness for which benefits are otherwise payable under the Policy. The primary result of the procedure is not a changed or improved physical appearance.
- 5. Custodial Care.
 - Care provided in: rest homes, health resorts, homes for the aged, halfway houses, or places mainly for domiciliary or Custodial Care.
